

## THUNDER BAY LAW ASSOCIATION GOLF TOURNAMENT

**Date:** TUESDAY, JULY 23, 2019 1:30 p.m. - 3:25 p.m. (Tee-off times on 9 minute intervals) RAIN OR SHINE

**Location:** FORT WILLIAM COUNTRY CLUB, 1350 Mountain Road, Thunder Bay (475-4721)

**Eligibility:** Anyone who, in any manner, is a member of, or is employed by, or works for Law Offices, or the Court Houses, or the Registry Office, or Legal Clinics, etc. etc. This includes the Court Reporters, Conveyancers, Sheriff's Officers, Registry Office Personnel, Provincial Court Staff, Guards, Judges, Law Office Staff, etc. etc. in the NorthWest Region.

**Entry Fee:** Golf Alone: \$ 60.00\* 9 Holes (FWCC members do not need to pay the green fees  
BUT shall pay only \$10.00)  
Dinner Alone: \$ 45.00\* Fabulous chicken dinner, along with free dessert (and coffee!)

Total Golf & Dinner: \$105.00 [PAYABLE to Kevin Brothers Professional Corporation]

\*Note: The fee is inclusive of HST and gratuities. If anyone wants to play eighteen holes, the cost is an additional \$20.00 (\$80.00 in total for 18 holes of golf alone). This is a very good deal!

**Prizes** Many and varied. This TBLA sanctioned event has to be self-funding, etc. (**Donations of prizes are greatly appreciated.**) There are, again, "huge" prizes.

**Format** Best shot per team. 9 Holes. (Exactly the same as in previous years). Please try to balance your teams but still include 1 or 2 reasonably fast (although they don't have to be skilled) players. Please remember that this event is still social and enjoyable, notwithstanding the competitiveness of some of the younger lawyers.

**Anticipated Questions:** Should I show up at least 20 minutes before my tee-off time? Is there an enforced dress code? **Should I send my entry fee in as soon as possible**, even if I don't have a team yet? Will I receive assistance in being placed with some pretty decent people/golfers if I cannot get my own foursome? Will the Provincial Court office staff be the life of the party? Will Carrel's or Buset's or Weiler's office likely get the prize for most the golfers in attendance? Will there be a count back used to determine the winner if groups are tied after 9 holes? Will the younger golfers, once again, dazzle with their wardrobe and ability to party? Will the awards presentation be kind and gentle? Is it amazing that the entry fee is the same as last year? Will Danny Johnson be performing again? Is the "betting" favorite Cheadles' team?
